

简 要 说 明

一、本篇资料反映陕西劳动就业与工资的基本情况。主要包括全社会就业人员数、城镇非私营单位就业人员数、城镇私营企业就业人数、城镇非私营单位就业人员工资、城镇私营单位就业人员工资、社会保障情况等。

二、本篇资料中，城镇登记失业人数、社会保障情况、城镇私营及个体就业人员资料由省人力资源和社会保障厅、省民政厅、省医疗保障局、省市场监督管理局等部门提供并加工整理。

三、统计范围和调查方法

1. 城镇非私营单位：指城镇地区全部非私营法人单位，具体包括国有单位、城镇集体单位、联营经济、股

份制经济、外商投资经济、港澳台投资经济等单位。工资统计是统计单位的就业人员，个体就业人员、自由职业者等非单位就业人员不在工资统计范围内。

2. 城镇私营单位：主要是指在内资法人单位中由自然人投资或控股，以雇佣劳动为基础的营利性经济组织，包括按照《公司法》《合伙企业法》《私营企业暂行条例》规定登记注册的私营有限责任公司、私营股份有限公司、私营合伙企业和私营独资企业。

根据统计调查制度，对一套表法人单位采用全面调查的方法，对非一套表法人单位采用抽样调查的方法。2020及以后非一套表法人单位不含5人以下的单位。

Brief Introduction

I. This chapter reflects the basic conditions of labour employment and wages of Shaanxi Province, mainly including the number of all employed persons, number of urban non-private units, number of urban private enterprise, wages of urban non-private units employed persons, wages of urban private enterprise employed persons, registered urban unemployment rate, the social security situation and etc.

II. The data on registered urban unemployment, social security, number of the persons employed in urban private enterprises and self-employed persons in industry and commerce are processed and prepared from figures provided by Shaanxi Provincial Department of Labour and Social Security, Shaanxi Provincial Department of Civil Affairs, Shaanxi Provincial Healthcare Security Bureau and Shaanxi Provincial Administration for Market Regulation and etc.

III. The Statistical Coverage and Investigation Methods

a) The urban non-private units: are all non-private

legal units in urban area, including state-owned units, urban collective-owned units, joint ownership units, cooperative units, foreign funded units and units with funds from Hong Kong, Macao & Taiwan etc. Wage of employed persons in urban non-private units are the persons employed in those units, except self-employed and freelancers.

b) The Urban private units: are established by natural person or controlled by natural person in legal units invested by domestic, are for-profit units based on wage-labor, including private limited liability corporations, private share holding corporations Ltd., partnership corporations and private sole proprietorship corporations registered in accordance with the "company law", "partnership enterprise law" and "Provisional Regulations".

According to the statistical survey system, the comprehensive survey method is adopted for a set of listed legal entities, and the sampling survey method is adopted for non-listed legal entities. Since 2020 and later, non-one set of listed legal entities do not include units with less than 5 employees.
